## **INSTRUCTIONS: NOTICE TO TAXPAYERS**

- 1. You are hereby notified to list your Tangible Personal Property, according to law, upon this form and to deliver this form with such list thereon to WARREN COUNTY ASSESSOR'S OFFICE, 105 SOUTH MARKET STREET, WARRENTON, MISSOURI 63383.
- 2. The law now provides for mailing the list to the property owner and everyone is responsible for making a return for assessment.
- 3. Show year, make and model of car or truck. The assessed value will be supplied by our office from the uniform AUTOMOBILE ASSESSMENT SCHEDULE provided by the MISSOURI ASSESSORS ASSOCIATION.
- 4. Penalties are provided by law for overdue, refusal or neglect to properly file a return under State Statute 137.280 RSMO.
- 5. The assessment listing should include all personal and tangible property under your control as of January 1st of the current year. All vehicles must be listed in order for you to obtain your license plates.
- 6. If you need additional assessment lists, please request one from our office or call the Assessor's Office so we can mail you one. (636) 456-8885 or (636) 456-4892.
- Manufactured homes shall be personal property, unless located on land owned by the manufactured home owner, and then they may be real IF converted to real estate as outlined under State Statute 700.111 RSMO.
- 8. Attach an additional sheet if more room is needed.
- 9. When filing a fraudulent list or willingly giving false information, the Assessor can double the assessed value under 137.285 RSMO.
